Title V RLIP (Rural & Low Income Schools Programs)

The purpose of the Rural and Low Income Schools (RLIS) program is to provide financial assistance to rural districts to meet local academic needs. RLIS funds a variety of activities including teacher recruitment and professional development, support for educational technology, parental involvement activities and more.

Eligibility Requirements: (must meet all requirements)

1a. All of the schools served by the LEA are designated with a school locale code of 32, 33, 41, 42, or 43, as determined by the Secretary of Education;

OR

1b. The LEA is located in an area defined as rural by the state;

AND

2a. Twenty percent or more of the children aged 5 to 17 served by the LEA must be from families with incomes below the poverty line.

Title V is an extension of Title I, Part A, Title II, Part A, Title III, Title IV, Parental Involvement Activities (Professional Development, Providing materials to help parents improve their child's academic achievement, enabling parents to participate in school related meetings and training sessions)

Bay City ISD will allocate Title V funds in the 2023-2024 School Year to help build our Parent and Family Engagement program by providing professional development, creating resources in the community, and providing the resources necessary to equip our families with the ability to support their children in school. This will help to improve academic readiness and improve attendance rates by forming relationships between the campus and the family.
